

Course Description

The Certified Trainer Authorized Person Series program is designed to prepare individuals to effectively deliver FallTech's 4-hour Authorized Person and 8-hour Authorized Person Advanced fall protection courses. The program begins with participation in a two-day Competent Person course to build a solid understanding of fall protection principles, equipment, and regulatory requirements. The following two days focus on preparing participants to confidently teach the prescribed fall protection curriculum. During this portion, a FallTech Senior Instructor will provide in-depth guidance on the structure, flow, and design principles of the program, along with practical strategies for delivering engaging, accurate, and compliant training sessions. Attendees will explore instructional techniques, classroom management practices, and course delivery methods that promote student participation and retention. By the end of the program, participants will be equipped with the knowledge, tools, and support needed to successfully lead Authorized Person training courses.



Duration: 4 Days

Course Objectives

- Develop an in-depth understanding of fall protection principles, equipment, systems, and regulatory oversight.
- Understand the scope and curriculum of FallTech's Authorized Person courses.
- Effectively navigate and utilize the trainer guides and instructor kit materials.
- Understand the basic principles of adult education and effective instructional techniques.
- Prepare delivery notes using the lesson plans to support course instruction.
- Practice delivering course content in a clear, engaging, and student-focused manner.
- Apply classroom management strategies to maintain an organized and productive learning environment.
- Understand how to use prescribed assessment tools to measure student learning outcomes.

Target Audience: This course is designed for safety professionals, supervisors, trainers, or any individual responsible for educating others. Attendees should possess a basic understanding of workplace safety and fall protection, as this foundation, along with the prescribed course curricula, will support the development of consistent, high-quality fall protection instruction.

Course Format: This course offers a balanced mix of classroom learning, hands-on activities, and practical exercises. Participants will explore fall protection concepts in an interactive environment while becoming familiar with the trainer materials they'll use when teaching others. Along the way, they'll have plenty of opportunities to practice, receive feedback, and build confidence, all leading to the successful delivery of an Authorized Person course.

Course Materials: Program attendees will receive a complete instructor kit with all materials needed for course delivery. The kit includes trainer guides, course outlines, equipment lists, testing materials, answer keys, and access to FallTech's custom Trainer Presenter tool for slideshow presentations. Participants will also have access to FallTech's Trainer Hub learning management system, which streamlines student tracking, recordkeeping, and certification, eliminating the tedious tasks of manual data entry. Course registration includes an initial supply of workbooks for the first course delivery, with additional workbooks available for purchase as needed.

Certification: Upon successful completion of the course, participants will receive a certificate of completion that demonstrates their ability to deliver FallTech's Authorized Person programs. This certification is valid for two years, after which recertification is required. Active trainers can maintain their certification through a simple, instructor-led online session, which provides recertification for both their end-user and Certified Trainer credentials in a streamlined and accessible format.
